A BILL

To prohibit the National Archives and Records Administration from including content warnings alongside founding documents of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the National Treasures Act
5 of 2021.

1 **SEC. 2. PROHIBITING NATIONAL ARCHIVES AND RECORDS**
2 **ADMINISTRATION CONTENT WARNINGS.**

3 (a) IN GENERAL.—Chapter 21 of title 44, United
4 States Code, is amended by adding at the end the fol-
5 lowing:

6 **“SEC. 2121. PROHIBITING CONTENT WARNINGS ON FOUND-**
7 **ING FATHERS DOCUMENTS.**

8 “(a) DEFINITIONS.—In this section:

9 “(1) CONTENT WARNING.—The term ‘content
10 warning’ includes any message preceding or attached
11 to a document that identifies or labels the document
12 as dangerous, harmful, anachronistic, or any other
13 term implying harm associated with the document,
14 disparaging the document, assuming malicious in-
15 tent on the part of the authors of the document, or
16 discouraging potential readers from reading the doc-
17 ument.

18 “(2) FOUNDING FATHER OF THE UNITED
19 STATES.—The term ‘Founding Father’ means any
20 individual who—

21 “(A) signed the Declaration of Independ-
22 ence;

23 “(B) served as an officer in the Revolu-
24 tionary War;

25 “(C) attended the Second Continental Con-
26 gress;

1 “(D) attended the Constitutional Conven-
2 tion; or

3 “(E) was granted a charter for 1 of the
4 original 13 colonies of the United States.

5 “(3) QUALIFYING DOCUMENT.—The term
6 ‘qualifying document’ means any document, text,
7 manuscript, book, letter, pamphlet, government doc-
8 ument, artifact, article of clothing, costume, or item
9 written in whole or in part, once belonging to, or as-
10 sociated with in public display a Founding Father of
11 the United States.

12 “(b) PROHIBITION.—The Archivist shall not—

13 “(1) attach to or associate with any qualifying
14 document written by a Founding Father of the
15 United States any content warning;

16 “(2) display a content warning as part of an ex-
17 hibition of any qualifying document is any public
18 display operated by the Administration;

19 “(3) display a content warning on the website
20 of the Administration or on any other website oper-
21 ated by the Administration; or

22 “(4) make any changes to the rotunda of the
23 Administration or any other space under their juris-
24 diction of the Administration that displays qualifying
25 documents to the public except insofar as changes

1 are necessary for maintenance, routine operations,
2 or repairs.”.

3 (b) TECHNICAL AND CONFORMING AMENDMENT.—

4 The table of sections for chapter 21 of title 44, United
5 States Code, is amended by adding at the end the fol-
6 lowing:

“2221. Prohibiting content warnings on founding fathers documents.”.
